#### Membership

Membership has grown to over 170 individual surveyors split across all four categories of; Oil & Gas Projects, Rigs, Renewables and Cargo. The numbers per category are as follows:

Oil & Gas Projects	149 members
Rigs	73 members
Renewables	33 members
Cargo	148 members

## Joint Rig Committee (JRC) announcement

The JRC made some changes to its suite of MWS technical documents in September of this year. The main changes include:

- consistent referencing to the Society of Offshore Marine Warranty Surveyors;
- alignment of the various Warranty Endorsements and Codes of Practice to ensure consistency;
- review and update of the Scopes of Work;
