## New Chairman and Vice Chairman of the Board appointed for 2020

The Society of Offshore Marine Warranty Surveyors (SOMWS) is delighted to announce that James Vavasour of MatthewsDaniel has been appointed as the new Chairman of its Board; and that Stephen Norman of Noble Denton Consultants Limited has been appointed Vice Chairman.

James is an expert in the international insurance market, having been with MatthewsDaniel for nearly 20 years. #### **Renewables**

According to research conducted by Rystad Energy, US investment in offshore wind could surpass \$15 billion by the mid-2020s, exceeding capital expenditure on offshore oil and gas. However, parts of Latin America have also secured a wave of



major offshore wind projects that require significant capital investment. As these investments play out and energy storage capabilities improve, we anticipate a tremendous shift in the adoption of wind power, both in the US and abroad. Offshore wind has been the focus of considerable innovation as it expands into deeper water and more challenging environments. This isn't the first time innovation and demand have pushed the limits in the energy sector, shifting from land, to shallow water, and eventually into ultra-deep water, as new resources become commercially viable. As the development of offshore wind shifts from a predominately European venture into a more global scale, there will be increasingly important crossovers of skilled

resources not normally associated with the renewables sector.

With conceptual designs such as TLPs, Semi-Submersibles, and Spars entering the renewables sector, this paper will discuss how industry can leverage decades of experience from oil and gas companies, their subcontractors and service providers, to the benefit of floating offshore wind. To help mitigate risks associated with these activities, SOMWS-qualified Marine Warranty Surveyors will be needed to support the global demand for offshore wind farms.
